RECOGNIZING THE ADMETECH FOUNDATION FOR HOSTING
PROSTATE CANCER AWARENESS DAY.

WHEREAS, ADMETECH WILL HOST PROSTATE CANCER AWARENESS DAY AT THE STATE HOUSE ON SEPTEMBER 10, 2009;
AND

WHEREAS, EACH YEAR IN THE UNITED STATES 1 IN 7 MEN IS DIAGNOSED WITH PROSTATE CANCER, AND NEARLY
30,000 MEN DIE OF PROSTATE CANCER ACCORDING TO THE AMERICAN CANCER SOCIETY; AND

WHEREAS, THIS YEAR IN THE COMMONWEALTH, THE AMERICAN CANCER SOCIETY ESTIMATES THAT APPROXIMATELY
3,800 MEN WILL BE DIAGNOSED WITH AND 530 MEN WILL DIE OF, PROSTATE CANCER; AND

WHEREAS, REGULAR PROSTATE SCREENINGS AND EXAMS FOR MEN, ALLOW FOR EARLY DETECTION OF PROSTATE
CANCER; AND

WHEREAS, SEPTEMBER IS NATIONAL PROSTATE CANCER AWARENESS MONTH, DEMONSTRATING AMERICA'S DEDICATION
TO IMPROVING THE DETECTION, SCREENING AND TREATMENT OF PROSTATE CANCER; NOW THEREFORE BE IT

RESOLVED, THAT THE MASSACHUSETTS GENERAL COURT HEREBY COMMENDS ADMETECH ON ITS PARTICIPATION IN
PROSTATE CANCER AWARENESS DAY AT THE STATE HOUSE ON SEPTEMBER 10, 2009; AND BE IT FURTHER
